

**Piece of Taylor Promotion
Official Rules**

NO PURCHASE REQUIRED. PURCHASING A CARDRUNNERS OR STOXPOKER MEMBERSHIP IS NOT NECESSARY TO ENTER AND WILL NOT INCREASE YOUR CHANCE OF WINNING. PROMOTION SUBJECT TO THESE OFFICIAL RULES. VOID WHERE PROHIBITED.

1. **The Prize:** The prize is one percent (1%) of aggregate tournament proceeds distributed to Taylor Caby at the final table of the Full Tilt Poker Million Tournament scheduled to commence on December 4, 2009, calculated in United States dollars according to Taylor Caby's finish place:

2. **How to Enter:** In order to enter, you must meet the eligibility requirements set forth below and be enrolled in Truly Free Poker Training by December 3, 2009 at 11:59:59 p.m. CST. Go to www.trulyfreepokertraining.com and provide the following information: your first and last name, email address, Full Tilt username, Full Tilt email address, and your primary account (either CardRunners or StoxPoker). You must create a free [CardRunners](#) or [StoxPoker](#) account if you do not already have one, and you must also create a [Full Tilt Poker](#) account if you do not already have one. **If you have already enrolled in Truly Free Poker Training, you will be automatically entered in the promotion. Limit one entry per person.** The odds of winning depend on the number of eligible entrants and the number of valid entries received during the promotion period.

3. **Eligibility Requirements:** You must be 18 years of age or older (or the age of majority in your state/province/territory/country of residence, if the age of majority is older than 18) and enrolled in Truly Free Poker Training by 11:59:59 pm CST on December 3, 2009. You do not need a paid subscription to CardRunners/StoxPoker to enter or win. The promotion begins November 18, 2009 at 12:00:01 a.m. CST and ends December 3, 2009 at 11:59:59 p.m. CST. Void where prohibited. Employees of CardRunners/StoxPoker and their immediate family members are not eligible to win. You will not be eligible for any prize and your entry will be disqualified if: (a) you do not comply with the CardRunners User Agreement found at www.cardrunners.com, or (b) you do not fully comply with these Official Rules, or (c) you are prohibited by law from entering the promotion in the jurisdiction in which you reside. The winner will be notified by CardRunners via email to the Full Tilt Poker email address used in connection with enrollment in Truly Free Poker Training. Only the natural person to whom that email address is assigned shall be eligible to accept the prize value described above, subject to Taylor Caby's finish place. In the event a potential winner does not respond within five days of notification or declines to accept the prize, the prize shall be forfeited and an alternate will be selected. 5. **Force Majeure:** Sponsor reserves the right, without prior notice and at any time, to terminate the promotion, in whole or in part, or modify or suspend the promotion in any way, if it determines, in its sole discretion, that the promotion is technically impaired or corrupted or that fraud or technical problems, or failures or malfunctions have destroyed or severely undermined the integrity and/or feasibility of the promotion. In the event Sponsor is prevented from continuing with the promotion as contemplated herein by any event beyond its control, including but not limited to tournament cancellation or delay, fire, flood, natural or man-made epidemic of health or other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state/provincial or local government law, order, or regulation, public health crisis, order of any court or jurisdiction, or other cause not reasonably within Sponsor's control (each a "Force Majeure" event or occurrence), then subject to any governmental approval that may be required, Sponsor shall have the right to modify, suspend, or terminate the promotion.

6. **Sponsor's Right and Disclaimer:** Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry processes or the operation of the promotion; to be acting in violation of these Official Rules; or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the promotion, or to annoy, abuse, threaten or harass any other person.
